i – Members had before them copies of the Corporate Plan 2017-2021. It was noted that while some objectives were still underway, it was important to celebrate the successes of the council, including the development of the Coneygear Centre and Crematorium. It was noted that an article celebrating the opening of the Crematorium should be put together for the Huntingdon magazine, as well as a press release for the Hunts Post. The Town Clerk noted site photos had been taken and an article would be put together.

ii – Members had before them a report from the Deputy Town Clerk containing recommendations for items to be included in the Corporate Plan 2022 – 2026.

It was noted that the council was still looking into the option of a tourist information centre in Huntingdon. The old Shoe Zone store had been considered, but was already leased by Wood Green. It was noted that the council would continue to monitor the situation with the lease of the Pizza Express unit.

The Town Clerk also informed Members that the council was able to obtain trees from the Woodland Trust to be planted at the crematorium site as part of the woodland burial area. This would form part of the Queen's green canopy for the upcoming jubilee celebrations.
